#### THE WARSAW UNIVERSITY OF TECHNOLOGY

Decision No. 123/2024 of the Rector of the Warsaw University of Technology of 11 June 2024

on the announcement of a programme supporting the participation of eminent foreign scientists and individuals with extensive industrial experience in research groups as part of the implementation of the "Excellence Initiative - Research University" programme at the Warsaw University of Technology

Pursuant to Article 23 section 1, in connection with Article 389 sections 1 and 2 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2023, item 742, as amended) and in connection with the Agreement No. 04/IDUB/2019/94 of 30 December 2019 concluded between the State Treasury represented by the Minister of Science and Higher Education and Warsaw University of Technology, it is resolved as follows:

§ 1

- 1. A programme to support the participation of eminent foreign scientists, including Polish citizens who have worked for at least 10 years in foreign research units and individuals with extensive industrial experience, in the work of research groups, hereinafter referred to as "the programme", is announced as part of the implementation of the "Excellence Initiative Research University" programme at the Warsaw University of Technology, hereinafter referred to as "IDUB".
- 2. As part of the programme, the heads of basic and university-wide organisational units of WUT may obtain funding for the employment of and conduct of research work by the persons mentioned in section 1.
- 3. The funding may be used for the remuneration under a job contract of a newly employed person, i.e. employed no earlier than within 3 months before the date of application, or of a Warsaw University of Technology employee whose employment terminates under a fixed-term contract no later than within 3 months of the date of application (does not apply to a change in employment conditions), to cover the maintenance costs of specialised laboratories (based on actual costs incurred by basic or university-wide organisational units) or to cover research costs (purchase of materials or access to research equipment and instrumentation). No funding is planned for the purchase of new research equipment and instrumentation.
- 4. The unit must evidence co-financing of at least 50%.
- 5. The call for applications under the programme shall be conducted continuously until the amounts allocated to it in the programme budget have been used up.
- 6. An application in accordance with the template specified in Annex No. 1 to the Decision is submitted by the head of the basic or university-wide organisational unit. The application is reviewed by the Steering Committee of the IDUB Project, which decides on the amount of the awarded funding.
- 7. To obtain the funding, it is indispensable to conclude an agreement in accordance with the template specified in Annex No. 2 to the Decision. The awarded funds will be transferred to the organisational unit of the Warsaw University of Technology indicated by the Applicant.
- 8. The allocated funds must be spent by 31 December 2025.

§ 2

The Decision enters into force upon signing.

- 8. Amendments to the provisions of this Agreement require the conclusion of an annex in writing.
- 9. Annexes to the Agreement shall form its integral part.
- 10. This Agreement has been executed in two counterparts, one for each of the Parties.
